TechCity – London



TechCityUK is a governmental initiative launched in March of 2011 aimed at turning the East London Shoreditch neighborhood into an international tech cluster. The initiative is run by the Tech City Investment Organization, a branch of UK Trade Investment (UKTI), and has drawn significant international attention since being heralded by David Cameron.

TechCity is not a physical location, but a concept driven by a team of people working to connect companies already within Shoreditch and to encourage other technology companies to move or start there as well. The ultimate aim is to increase the presence and success of digital startups in London through creating a digital hub akin to Silicon Valley in the US. The TechCity team's major activities include hosting and partaking in neighborhood events such as job fairs, conferences, international meet-ups and press events.

The neighborhood of TechCity has been both organic and planned. Initially, many startups within the city settled in that particular location due to the low rent, while now, companies are flocking to be in a dynamic environment amongst potential customers and collaborators. East London is also home to London's 2012 Olympic park, which will play a large part in future for TechCity, being converted to an accelerator space for new companies out of TechCity in order to continue to take advantage of the high tech communications infrastructure built for the Olympics.

The Tech City Investment Organization works very closely with politicians and has managed to help influence policy in a favorable direction for startups, including helping to establish an entrepreneurs' visa for non-Brits wishing to start companies in the UK, an R&D tax credit, and capital gains tax relief for startup owners. In the past year, the number of startups in East London has grown from 200 to 600, with some of those companies relocating from other areas of London, and other companies started within the community.

He is a Director for CREATE, the festival for the Arts that has grown out of east and south east London to engage the wider community as part of the Cultural Olympiad and as a legacy for the Arts to come from 2012.

He represents the Borough on the board of the Shoreditch Trust, a community led neighbourhood renewal initiative in Shoreditch and he is a member of the East London Business Alliance Hackney Forum, bringing social responsibility investment into the community alongside colleagues from the private corporate sector. He co chairs Hackney's successful Economic Development Partnership, part of the Borough's strategic partnership, which tackles unemployment and encourages enterprise in the Borough. Mark Kleinman is Assistant Director of Economic and Business Policy at the Greater London Authority (GLA). Mark joined the GLA in November 2009. Mark heads up the GLA's Economic and Business Policy Unit, which is responsible for providing an integrated policy development and delivery service to the Mayor and his office across the whole field of economic and business policy.

Mark started his career as an academic including teaching for eleven years at the London School of Economics where he was involved in urban policy and urban economics, particularly London-based research and policy advice. His time at the LSE included the period leading up to the creation of the GLA. Mark then became Professor of International Social Policy at the University of Bristol, and subsequently took various roles in government, starting with a year in the Prime Minister Strategy Unit working on migration policy. Mark moved to the GLA in 2003 to be Head of Housing and Homelessness. Mark then moved on to work in the Office of the Deputy Prime Minister (now the Department of Communities and Local Government) where he was Director of Urban Policy.
