## Visit to Singapore by the City of Stockholm April 4-5 2016

The Chief Information Officer of the City of Stockholm will be leading a delegation to visit Singapore during the 4<sup>th</sup> -5<sup>th</sup> of April. The purpose of the visit is to further enforce and develop the relationship between Singapore and Sweden, specifically in regards to the subject of Smart Cities.

Stockholm, with its 900,000 inhabitants, is the largest municipality in Sweden. The City Council is the supreme decision-making body of the City of Stockholm. The City Council provides the inhabitants of Stockholm with a multitude of different municipal services. Most of the municipal activities in Stockholm are carried out in administrative or corporate form. The delegation consists of representatives from the executive office of the City as well as representatives from administrations and companies owned by the City.

The City of Stockholm has in its Vision for 2040 set out the ambition to become the smartest city of the world. Therefore the management of the city is currently forming a strategy to reach this ambition.

A delegation will travel abroad to visit a few selected cities and countries to learn and share best practices for smart, sustainable and connected cities. Singapore is the first country for such a visit.

During the course of the visit in Singapore, the delegation would like to meet with Minister Vivian Balakrishnan, Minster-in-charge of Smart Nation. The delegation would also like to conduct roundtable discussions inviting the Smart Nation Program Office and the Infocomm Development Authority. Furthermore, when forming the strategy for Stockholm as a smart city various areas are of interest. Therefore the opportunity to meet with ministries and statutory boards to discuss topics such as ageing, urban transportation, energy

and green building would be of great interest to the delegation. Lastly, the delegation would like to meet with Swedish business representatives based in the region as it offers an opportunity to learn more about how Sweden and Singapore may work together to increase future trade relations.
